- ✓ Proof of qualifications and training certificates for all therapists of the salon (Non-members and Associate Members only - Insured members do not need to supply these as we have them on record)
- ✓ Membership certificate (members) or Proof of insurance (Non-members or Associate Members)
- ✓ Signed terms & conditions
- ✓ A portfolio of evidence to support your application

STEP 5: Send **all** the above information to <u>awards@babtac.com</u> by **30**th **November 2021**.

What happens next?

- The entry deadline is 30th November 2021. After the deadline, our judges will consider each submission and its supporting evidence.
- 2. If you are chosen as a **semi-finalist**, you will be notified around the 10th January 2022 and may be asked to provide further information required ahead of choosing our finalists
- 3. The finalists will be notified at the beginning of April 2022. The winner will be announced at our prestigious Annual Awards Ceremony at The Fairmont Windsor Park on the **8th May 2022**.
