BABTAC & CIBTAC AWARDS 2018/19 - TERMS & CONDITIONS

Conditions for entering and applications

- No family members, employees or councillors of BABTAC or CIBTAC can enter
- 2. No students or employees from BABTAC or CIBTAC council businesses can enter
- Entrants can enter a maximum of three award categories only. If an entrant submits applications for more than three categories the judges shall choose three category applications and discard any remaining, which three categories are chosen is at the total discretion of the judges and feedback will not be provided
- All entrants must be over the age of 16
- Entry photographs cannot be digitally or otherwise enhanced. Any photographs deemed to be digitally or otherwise enhanced will be disqualified
- The entry deadline for applications to the 2019 awards is 30 Nov 2018, no late entries will be accepted under any circumstance
- You may win a BABTAC & CIBTAC award category three times, after which you will be entered in to the BABTAC & CIBTAC Awards Hall of Fame and therefore unable to enter future BABTAC & CIBTAC awards for that category
- All written information submitted will be confidential
- All entrants must have adequate industry insurance and training, and proof of valid insurance must be submitted at the point of application, failure to do so may result in disqualification
- 10. It is the entrant's responsibility to enter the correct category and provide all the required and valid information
- 11. Only current CIBTAC students (or qualified in the 12 months prior), tutors and centres can enter the CIBTAC categories
- 12. Only current BABTAC members can enter the non-CIBTAC categories
- 13. All entrants must submit a signed and dated copy of these terms & conditions at the point of submitting their application. Failure to do so will result in disqualification

Judging process, trade tests and site visits

- 14. Winners will be announced at the celebration & awards ceremony in September 2019
- 15. The judges' decision is final. No correspondence will be entered in to after the judging period. Judges will sign a confidentiality agreement and therefore will not be allowed to enter in to any communication with entrants with reference to the awards
- 16. Winners and finalists will be entitled to use the BABTAC & CIBTAC Awards 2019 logo along with the relevant category heading for promotional use. No alterations can be made to the logo. The year in which the award was won must always been stated
- 17. Semi-finalists in the following categories will be required to attend trade testing at BABTAC Head Office between $18^{th} 29^{th}$ March 2019: waxing, beauty therapist, make-up artist, holistic therapist, lash specialist, nail technician, brow specialist and specified innovators. Details of the date for each category will be confirmed with the semi-finalists and a minimum of two weeks' notice will be provided. Failure to attend the trade test will result in disqualification
- 18. Semi-finalists are required to bring their own equipment, products and supplies to the trade test
- 19. Semi-finalists and Finalists will be expected to pay for their own expenses including travel, catering and lodging. In the event of a cancellation there will be no reimbursement
- 20. Large salon, small salon, specified innovator, spa and advanced aesthetician semi-finalists will have a site visit from a judge as part of the judging process. All treatments performed during the site visit will be free of charge and any costs incurred will be covered by the entrant **not** the judge **or** BABTAC & CIBTAC
- 21. All semi-finalists must provide models for trade tests and site visits and cover any costs incurred themselves. Failure to provide a model for trade testing or site visits may result in disqualification
- 22. Although every endeavour will be made to do so, BABTAC & CIBTAC may be unable to inform all those that do not make it to the semi-finals. If you have not been notified that you are a semi-finalist by 25th January 2019 then you must assume you have been unsuccessful on this occasion
- 23. Due to the high volume of entrants to the awards, BABTAC & CIBTAC are unable to provide feedback to entrants who are not shortlisted to finalists. Those who are shortlisted to finalists will be able to request feedback for a period of 1 calendar month following the date of the awards ceremony. Granting feedback requests is at the discretion of BABTAC & CIBTAC and may be withheld without prior notice
